Our Work

Literacy Outreach Coordination: We support a network of 98 Literacy Outreach Coordinators who work in over 400 BC communities. The numbers below show the activity throughout the network in the 2021-2022 program year:

- 1,948 community members worked on community literacy action plans.
- 11,548 adults engaged in improving their reading, writing, technology and financial skills.
- 18,987 adults engaged in their children's learning.
- 27,607 children engaged in early literacy learning.
- 17,704 school-aged children and youth engaged in improving their reading, writing and financial skills.
- 5,808 seniors engaged in improving their reading, writing, technology and financial skills.
- 55,351 people participated in literacy related workshops, seminars and events.

Connecting for literacy at Decoda Conference



In May, literacy practitioners from across B.C. and Canada gathered for professional development and connection at the Decoda Literacy Conference in Richmond. The energy, inspiration, connection and learning during the three days are sure to have a ripple effect on community literacy programs across the province.

The conference offered IPALS training, Displaced Workers Project findings, a choice of 31 workshops and keynote speakers Dr. Ralf St. Clair, Craig Alexander and Angela Sterritt.

"It's been an exciting conference," said, Brigid Hayes, a Canadian literacy expert and As I was saying ... blogger. "I'm really impressed with the range of topics discussed, like digital justice and trauma-informed practice. I've learned an awful lot here. And talking to people on breaks and at lunch – that stuff you can't do on Zoom. It's just so refreshing to meet in person again, and I want to thank Decoda for having me."







Working together for literacy

Decoda provides valuable services to the literacy network and the community at large.

- Fostering Literacy supports children (in particular, those in care) who struggle with reading by providing one-to-one sessions with trained tutors in 18 communities.
- Immigrant Parents as Literacy Supporters (IPALS) is s play-based, bilingual
 family literacy program that helps immigrant and refugee families prepare
 their children for school in Canada in 18 communities. This year, Decoda
 partnered with a research team at UBC to begin a study on the best ways
 to help integrate immigrant families into Canadian society.
- The Westcoast Reader is a newspaper and online resource for learners of all ages, with a print distribution of over 13,000 copies per month in addition to digital access for subscribers.
- Displaced Workers is a research project with Essential Skills Development Canada designed to identify supports for workers who have been displaced to improve their employability.
- Decoda provides BC's 97 Community Adult Literacy Programs (CALP) with training, resources and support.
- The Decoda Literacy Library has over 6,000 literacy resources free to borrow anywhere in BC.






